1. Financial Report

- A. We have \$25,738.08 in our account as of August 01, 2025. Nicole just transferred \$1,470 from our 12u tournament shirts into our account to make our new balance \$27,208.16. We still have the \$10,000 in our account for the grant the Varsity team received. Motion by Amy, seconded by Megan, to approve the financial report. Motion approved.

2. Approval of Minutes

- A. Motion by Nicole, seconded by Amy, to approve the June meeting minutes. Motion approved.

4. Old Business

If she is voted in, the vice president position will need to be filled. We will have a special meeting on August 10, 2025 at 4pm for voting. Anyone interested in running for the open board seat will need to submit a letter of interest by Friday, August 08, 2025.
- C. We will have 2 more signups for fall ball: Thursday, August 07, 2025 from 6pm – 7pm and Sunday, August 10, 2025 from 3pm – 4pm. Both signups will be at the pavilion at the sports complex.
- D. We will be doing a cash raffle ticket fundraiser to try to make up for the concession stand profit loss. They will be \$5 a ticket and drawing will be held on October 08, 2025. Prizes will be \$150 for 1st, \$75 for 2nd, and \$50 for 3rd.
- E. Mary and Megan have been talking about the craft show for this year. We are going to try and get the Greenville VFW either November 22nd or December 6th. Will update next meeting.
