1. Financial Report

A. We have \$13,461.87 in our account as of January 31st. We did receive the \$10,000 for varsity that is going to be put into our account. Motion by Michelle, seconded by Jaci, to approve the financial report. Motion approved.

4. Old Business

- A. Steve is waiting to receive the equipment from 10u. He is hoping to have everything before the next meeting.
- B. Uniforms have been picked and we are waiting for sizing kits to come in so girls can try on jersey's and pants at evaluations.

C. Spring season:

- a. Uniforms have been picked and we are waiting for sizing kits to come in so girls can try on jersey's and pants at evaluations.
- b. Amandia wasn't able to make the meeting so we will get an update on the dunk tank at the next meeting.
- c. We are still working on scheduling the AED/CPR/First Aid training. Will update next month with a definitive date and time.
- d. Evaluations are scheduled for February 8th at the Greenville Elementary School. There will be a make up date scheduled as soon as we secure a location. Mackenzie Herman, the 14u coach, her Dad (the other 14u coach), along with 3 of her teammates from the Thiel Softball Team will be evaluating the girls. Greg said that he doesn't think the Thiel players are able to evaluate correctly being they are only 18-20 years old. Said he'd rather see coaches

from around the area do it so they can evaluate fairly. Steve said that we asked Thiel because they don't have bias and can judge fairly being a neutral party. Michelle said she doesn't want people to threaten her family again like what happened in the fall.

- e. Steve said that he will have field maintenance costs at the next meeting. He said last year it was \$750 for dirt and it went up 10% this year. We are almost out of lime. We are also looking into field dry for the season to help with all the rain. He is getting pricing for 9 pitcher's mounds.
- D. Steve is going to get everything off Nicole to take to Jessica for the audit.
- E. We received 2 bids for the dugouts. McCann Masonry and Contracting for \$44,325 and Brian Pressler Construction LLC for \$29,750. We will send it out for rebid once we received some grant information.

5. New Business

- A. It is \$725 to renew our insurance with Erie Insurance with \$1 million in coverage. Motion by Amy, seconded by Michelle, to renew our insurance.
- B. Reynolds has 5-6 girls for 14u and they asked if we would be willing to take them. Amy asked if they join us if they would be with us for the duration. According to the County, if you can't field a team they are able to play elsewhere. If the following year, they are able to field a team, they can go back. Jaci said she would rather have girls play with who they're going to play with in Greenville. Michelle said she would rather have our girls double roster. As of right now our numbers are:
 - a. 8u 12 girls
 - b. 10u 10 girls
 - c. 12u 10 girls
 - d. 14u 6 girls
- C. We will need to renew our agreement with the Borough in April.

6. Open Discussion

- A. Our numbers will dictate how many teams we will have. We will pick coaches after Wednesday.
- B. Mackenzie said she would be interested in coaching 12u if we don't have anyone else.
- C. Michelle said that we need to have the 8u girls that want to move up pitched to by a 10u pitcher.
